## **Declaration of Conformity – RoHS**

Herewith we confirm the conformity of our products with the Restriction of Hazardous Substances (RoHS) Directive 2011/65/EU and the directive 2015/863/EU of the European Parliament and the Council for restricting the application of hazardous substances in electric and electronic devices.

We further confirm the compliance of our products with the permissible ceiling concentrations in homogenous materials in weight percent as follows:

< 0.01 % for Cadmium < 0.1 % for Lead Mercury Hexavalent Chromium (Cr6+) Polybrominated Biphenyl (PBB) Polybrominated Diphenyl Ethers (PBDE) Di Phthalates (DEHP) Benzyl Butyl Phthalates (BBP) Di Butyl Phthalates (DBP) Di Isobutyl Phthalates (DIBP)

according to Attachment II of the directive, eCOUNT embedded GmbH confirms that all products, unless otherwise noted, are produced in compliance with RoHS.

Since the presence of the above mentioned substances can't reasonably be expected, eCOUNT embedded GmbH doesn't systematically check their absence by testing.

Exceptions according to Attachment III of the directive, paragraph 7a: Articles which require the application of high temperature plumb with lead content >85% belong to the exceptions and comply with RoHS as well.
